It seems that there is a lot of confusion surrounding the facts in regards to Cen Biotech and representation of shareholders. I and other family members have been shareholders since January 2, 2014. I would like to start by saying that it does not seem that shareholders are being fairly represented. I think that the real questions that need to be asked are: How can Health Canada issue a ready to build letter and request an expedited build out and then drop communication with Cen Biotech and issue a denial with no explanation of the caused deviation from the process of approval, How can the township of Lakeshore issue the building permit for the facility and hold a publicly televised welcoming meeting for the endeavor and then claim that they where not aware of Cen Biotech's intent.

I believe that Bill Chaaban has been honest and transparent throughout this process and that the actions of a Mayor Tom Bain of Lakeshore Ontario and The Officials of Health Canada are where an investigation should take place. Documented actions of the previous twenty four months do not show continuity of commitment by The town of Lakeshore or Health Canada.

To Whom it may Concern:

In February of 2014 I became aware of Cen-Biotech (FITX) from an article on Yahoo. I am from Grand Rapids, Michigan, and because it started out as a Michigan company I became curious and did research on this company. I decided to invest in the company because everything I saw looked positive and I expected good results.

During this ordeal, the one bright spot was Bill Chabaan. He never led me to believe that this company that he headed was in any way untrustworthy and I feel he has been honest with me. None of his and the company's press releases led me to believe otherwise. I still believe in him and this company. I truly feel that he kept us in the loop without giving away classified information.

Unfortunately as it turned out, it seemed that a group of people do not want this company to succeed. Article after article cut this company down. I watched the value of my stock fall from 9 cents a share to less than a penny a share. To put it mildly I am totally disgusted with the way our stock has been manipulated by many different sources, including in my opinion, the Globe and Mail and Grant Robertson. There has been market manipulation par excellent by them. As article after article ripped my company, my stock went even lower.

I follow stock message boards, and this jumped out at me when it happened. On and around Feb 12 on the Yahoo board a whole group of new screen names that I had never seen before began posting positive things about the stock. Within the next two days the share price had increased by at least 40%. At that time millions of shares were bought just before the market closed. Then after the market closed on the 13th and before CEN had a chance to be notified and respond, the Globe and Mail released an article stating that CEN was being denied a license to grow medical marijuana. By Monday the 16th my stock was worth many thousands of dollars less than it had been on Friday. It is my belief that those screen names were hired by somebody connected with Grant Robertson to manipulate the stock price.

I want a thorough investigation of Grant Robertson and the Globe and Mail as well as the public stock boards. I feel anybody involved in the manipulation should be arrested. Also to be arrested is the person or persons leaking information to them from Health Canada. The Globe and Mail got the information from Stephane Shank of Health Canada about our license denial before we even received it.

Let me repeat this again: I want a thorough investigation of these people and that criminal proceedings will be brought against them if so warranted.

evidenced by the Health Canada leak of sensitive information to Grant Robertson of the Globe and Mail. The root instigators of this effort to shut down Cen Biotech has not been discovered as of yet, but hopefully the criminal element will be made known and held accountable to the company, the shareholders and the Canadian public with the help of courts and other entities if we can find any honourable agencies with integrity which we hope the OSC is.

There is a large group of shareholders of all creeds, colours, nationalities, religions, and beliefs, that can't believe Canada and certain parties within, a seemingly just, honourable, advanced democratic society, can behave, manipulate, and purposely, criminally, try to destroy a company that has followed the rules, requirements, codes of conduct, in an effort to create medicine to help save lives and comfort the ill. They act at will without any ramifications and are the true manipulators of the stock for their benefit. Dear whomever it may concern,

As a previous FINRA licensed 6, 63 & 65 I can tell you that the things I have seen against Cen Biotech have broken many laws for trying to manipulate a stock price from forums to using social media including articles written from newspapers. I started investing in Cen Biotech back in January of 2014 where the company had proposed to obtain a grow operation in Canada. The town of Lakeshore including the mayor seemed firmly behind the company and so did locals. I have never met anyone who works for Cen Biotech but clearly see their vision and believe they have done things right.

I will start from the beginning since quickly noticed a forum investorshub.advfn.com (IHUB) attacking the company relentlessly on falsified information to benefit from and not limited to Cen Biotech early spring of last year. A group of posters that I quickly realized were pumpers/bashers were using that forum to benefit themselves financially. I watched one day on FITX board where five people bashed the stock relentlessly saying completely off the wall false misleading information so someone could put up a large amount of shares on ask to allow someone to cover. Right after the cover happened I noticed they stop postings on that forum quickly and moved to another page. They continue to use this forum even to this day to manipulate stocks for the benefit of themselves. I know this forum has been in many serious issues already but when you address a concern to administrators they just ban you from the page and limit your posts. Some of the bashers started postings statements as in they had contacted the local government of Lakeshore and told them why this company should not be licensed. They started quoting statements from Steve Salmon who previous year (2013) addressed the zoning concern in an article as stating zoned properly. I know the town of Lakeshore got overwhelmed by these people relentlessly calling the office but to me I believe someone started paying some of the officials including many people on the council since their views on the project completely changed. In one of the council meetings you can hear one of the council members state how their decision will effect the price tomorrow in a laughing manner. I completely feel every person on Lakeshore council should be investigated financially including immediate family members.

Another red flag was a letter that I emailed Ms. Wolfstein a writer for the Windsor. I asked for information after she wrote an article stating the town had changed views on proposed site for Cen Biotech. I quickly reached out to her asking for details where she stated to me that you shouldn't be investing in public companies but the private ones. I emailed her back asking which but she never did and after doing digging I believe she has ties to the company Aphria which is located not to far from Cen Biotech location. At this time Aphria was a privately held company and not publicly traded. I sent my information to the Cen Biotech explaining my concern.

Matt Finston a writer for Seeking Alpha quickly started bashing FITX from middle of last year. Matt Finston wrote many falsely and misleading articles from stating where insiders had sold shares trying to cause panic but the filing was for potential sale of shares. Matt Finston is another person who I believe has financial gain from this company downward fall since during a late night twitter feed during the time where Hamdan had filed suite for slander a poster wrote on his feed stating keep it up you will have a job with Globe and Mail one day. The tweet was deleted quickly and I never got a record of it. This person needs to be investigated since he is being fed information from a group or someone since his writing skills have changed clearly from early on.

I believe Alan Brochstein is involved with this group of people owner of 420Investors.

Grant Robertson writer for Globe & Mail who started writing articles against Cen Biotech starting December of 2014 has clearly shown he isn't doing this for kind of his heart. I have never seen a writer write so many articles in short period of time against one company in my years on this earth. I truly believe he is financially benefiting from the private US company Privateer Holdings <http://www.pnewsire.com/news-releases/privateer-holdings-canadian-subsiary-tilray-opens-10-million-cannabis-facility-in-british-columbia-256367291.html>. As you

know Privateer Holdings met with Health Canada to discuss how to privately invest in Medical MJ companies. This is the main company that I believe is behind the attempt to destroy Cen Biotech. Grant Robertson has clearly shown he receives insider information from Steven Stephane an employee at Health Canada who is the person that told Grant Cen Biotech was getting a rejection letter. Clearly this is a violation of privacy according to Health Canada website stating they will not release information to anyone except applicants.

Canada's politicians. Libby Davies is on record with meeting a lobbyist for Tilray who was quoted in a Grant Robertson article against Cen Biotech. Clearly why would a politician who isn't seeking reelection get involved with such a topic unless she had something to gain from it? I clearly believe she is being financially compensated by someone. Past CEO of Tweed Chuch Rifici <http://www.discoversmithsfalls.ca/chuck-rifici-resigns-tweed-ceo/> who clearly is anti Cen Biotech from his twitter feed has shown why a past CEO and current owner of a company over 20% Tweed shouldn't be in politics that has such influences on a government agency. To me his statements about Cen Biotech on twitter feed clearly shows he is involved with the big group of getting Cen Biotech out of the room and has a conflict of interest at his current job.

In conclusion ask yourself why would any of these people care if Cen Biotech got licensed? Well clearly when a company has applied for the largest licenses and demonstrated global networking then you become a huge threat. I truly believe a group of companies currently licensed came together to get rid of the big gorilla in the room so they could own the market share. I believe they have paid off from local governments to writers for national newspapers. I believe they will do anything in their power to stop Cen Biotech from making falsified and misleading statements because not millions but billions are on the line here. I personally have been attacked from spending weekends protecting my identity since people were trying to hack my personal Facebook page to my email address including family portraits being sent to me of my family. I have contacted my local authorities on the matter. No company or person is perfect but to me if you look into Cen Biotech no doubt you will see a company that has been targeted since billions are on the line.

As a shareholder of Creative Edge Nutrition/Cen Biotech Inc, (ticker symbol FITX), it has come to my attention that there is possibly an ongoing OSC investigation into non-specific company activities. I would like to take a moment to tell my story and give my opinion of the company and CEN Biotech CEO, Mr. Bill Chaaban. I am merely a FITX shareholder and have never met or spoken with Mr. Chaaban or any FITX employees, officers or members of the board.

I first invested into FITX in Oct of 2013 after my research led me to CEN's intention to seek a MMPR license in Lakeshore, Canada. Since that day, I've followed the company through multiple internet forums/boards, sometimes several hours daily and rarely missing a day. As word spread of CEN's plans and potential, so did the bashing and naysayers. However, through my own DD and that of other longs on the FITX boards, my confidence in CEN and Mr. Chaaban grew. It was clear to me that CEN was a legitimate company and Bill Chaaban was an honest CEO who cared deeply for shareholders and was passionate about building a top of the line company. Since my initial investment, I've added to my share count many times at various PPSs, up to 10 cents, and continue to add shares as I can afford to do so. If it is any indication of my confidence in CEN and Mr. Chaaban, I submit that I have never, and I emphasize NEVER, sold a single share of FITX, even when I was up thousands of dollars, and I do not regret buying any of my shares.

Late in 2013, after CEN received their "Ready to Build" letter from Health Canada, Mr. Chaaban worked diligently to build everything he promised to the shareholders, and I feel he did just that while keeping shareholders updated about their investment. However, all along the way, CEN was met with lies, resistance, libel and corruption. Since day one, an online trading forum, "Investors Hub", has and continues to consistently allow and encourage (through their biased mods) bashing of CEN, harming the PPS. The town of Lakeshore invited and welcomed CEN to their town to build a MMPR facility but after CEN spent millions of dollars on the build out, the town is now trying to change the rules. Several newspaper and internet bloggers wrote multiple bashing articles for months, mostly without

evidence, and to anyone who reads these articles it is blatantly obvious they are personal attacks on Mr. Chaaban and CEN. Health Canada provided CEN with a "ready to build" and let them spend millions of dollars on a build out, then denied a license even though their own inspector recommended to grant a license. With such an onslaught of bashing and corruption against Mr Chaaban and the CEN, the only thing they are guilty of is trying to defend the company and it's shareholders. I can honestly say that I am not aware of ever being lied to or misled by CEN or Mr. Chaaban.

I welcome the investigation into CEN and those that have unfairly caused damage to it's well being and it's shareholders. I implore the OSC to get to the bottom of the corruption that has been plaguing CEN since they started their quest to build the largest and most advanced medical marijuana facility in the world. I have hundreds of hours of DD invested as a FITX long shareholder and can say, in my opinion, that the only wrongdoing that has been committed here has been against CEN, Bill Chaaban and the FITX shareholders. If the shareholder is of the utmost concern to the OSC, I urge a quick but thorough investigation. If wrongdoing is found to have occurred against CEN, those responsible should be punished to the fullest extent.

To Whom it Concerns:

I have become aware that the OSC is interested in the facts surrounding the Cen Biotech situation. First, let me say as a Canadian and shareholder, I am appalled and sickened at the conduct of Health Canada, Town of Lakeshore, the Globe and Mail and their employee Grant Robertson. I started doing research on this company in the fall of 2013 and spent hundreds of hours studying the new MMPR regulations being put in place in the spring of 2014, the companies objectives and qualifications, plus the site, zoning, and general ramifications of the industry through the endorsements of the Town Council of Lakeshore and it's Mayor Tom Bain and the regional council I should add. The Town in association with Health Canada approached the Cen Biotech Group to create this facility on property chosen by Town Council as appropriate in terms of zoning and the business application and size. After a 900 page application was submitted to Health Canada that passed all criteria for a license, a ready to build permit was issued from Health Canada to the Cen Biotech group. The Town of Lakeshore issued a building permit and held a big press conference welcoming the new industry and congratulating themselves on the hard work it took to get this done. Health Canada urged Cen Biotech to expedite the build out of the first building to facilitate the expected market that the new medical marijuana laws would create. During this process, Mr. Chabaan was very transparent to the shareholders, posting documents as they arrived and discussing issues with shareholders and any people who took issue with this new start up firm. He held an open house at the plant for shareholders, and invited specific aggressive opponents to either come to the plant or to meet with him to discuss their issues. He hired the best people in the field that he could find to create a stellar Board of Directors. They spent a considerable amount of money based on the approvals and encouragement of authorities and many of us invested based on the same encouragements of the authorities - not Mr. Chabaan. After the plant was completed and had passed all the Town Inspections at the end of April, the company was forced to wait three months for Health Canada to show up and inspect the facility. What type of entity abuses power like that. They encourage a company to spend millions of dollars to create a state of the art facility, expedite the build out, then ignores them for months, contrary to there own guidelines. Due to this failure on Health Canada's part, market manipulation and constant bashing by certain websites and individuals started to benefit their efforts as this was a highly anticipated and expected start up with a vast following of potential investors and those already invested. It was also at this time that Council of Lakeshore started to mysteriously change their feeling toward the facility and it's location, who also began to suffer memory lapses when it came to their own approvals, recommendations and blessings given in the prior 6 months. Every public comment Mr. Chabaan made in regards to any situation, was manipulated by the opposing forces to suit their agenda of manipulating the stock price or hurt the reputation of Mr. Chabaan and the company. After Health Canada inspected and approved the facility with two very minor adjustments required, the license was expected to be issued very shortly thereafter, according to their guidelines and Mr. Chabaan reported this to the shareholders. A spike in the share price occurred due to the inspection and the positive report, and would have occurred with or without a public comment by Mr. Chabaan as this was highly anticipated across the market. The license never came, and then a coordinated attack by Grant Robertson of the Globe and Mail started, accusing Mr. Chabaan of all sorts misleading statements in order to benefit from insider sales etc. Well, let me tell you, Mr. Chabaan has not made a statement that wasn't based on information issued by Health Canada or assurances given by the Town of Lakeshore. It has come to my attention that CEN-Biotech is under investigation by the OSC. I am writing to you as an owner of CEN-Biotech, in full support of the company. As an owner, I saw steady progress on construction of the facility (following full approvals from the Town of Lakeshore and the issuance of a Ready to Build letter by Health Canada). Things were coming together for the company. Mr. Chabaan was actively involved, domestically and internationally, in industry networking and acquisitions. An experienced board of directors was recruited, including in April, 2014, John A. Germinario, a global capital markets securities fraud examiner who worked with the U.S. Securities and Exchange Commission (SEC) and the Internal Revenue Service (IRS) Whistleblower to identify multiple levels of securities, bank and tax fraud. Dr. Jonathan Lakey was added to the medical team in August 2014, to research initiatives in marijuana & hemp plant stem cells and the effects of Medical Marijuana on stem cell development. This caliber of individual would not put their reputations on the line for a company, were it not legitimate.

Progress continued steadily and correlated accurately with every announcement made by the company. The wait for inspection was months, rather than days or weeks as expected, despite the facility being ready for inspection. When Health Canada finally did come to inspect on July 31, 2014, the report stated that approval was recommended pending the correction of 2 minor issues (a screen over a vent, and the security camera angle). The wait began again for final approval, even though the minor issues were immediately fixed.

During the months of delay, the Town of Lakeshore began to change their stance. They initially recruited and welcomed the company to Lakeshore and granted approvals and building permits for the facility build-out. After months of delays, due to Health Canada's lack of action, a few nearby residents, despite observing months of construction activity on the site, began to complain. They claimed that they knew nothing about the nature of the project and were opposed to having a marijuana grow facility in the area. A letter, provided by CEN-Biotech to the town councilors, revealed that the complaining neighbors had requested significant monetary compensation and guarantees of employment in return for their support of the company's operations. Council has passed an Official Plan Amendment and Zoning Bylaw Amendment to provide for the establishment of Health Canada licensed facilities, under the new Marijuana for Medical Purposes Regulation (MMPR) and Industrial hemp Regulations at its Special Meeting of November 4, 2014.

Council has provided for the establishment of licensed Hemp facilities in Agriculture designated / zoned lands only and, licensed Marijuana facilities in Employment designated/ zoned lands only. All proposals for these facilities will be considered on a site specific basis (a zoning by-law amendment is required to permit these facilities).

Council's decision on the Official Plan Amendment (OPA No. 6) will be forwarded to the County of Essex, the Upper Tier Municipality, for consideration and approval. The County will publish a decision on OPA No. 6 in the near future, with a 20 day appeal period. The Zoning By-law does not come into effect until the Official Plan Amendment has been approved by the County and is in "full force and effect".

The subject North Rear Road properties are zoned and designated Agricultural and the current structures are consistent with the designation and zone. However, the growing or processing of medical marijuana at these sites would not be permitted under their current zoning. An applicant would be required to apply for a Re-zoning of the site .They are not 'grandfathered' under the Council amendment.

Cen Biotech's application for a MMPR license, without giving any tangible reasons. The stock dropped 62% from February 13 to March 17 as a result of this action.

The bloggers have kept up a constant attack on Cen Biotech throughout this whole ordeal. They have made outlandish claims & stated them as fact with no proof to back them up. There are three in particular that seem to have made it their life's ambition to destroy Cen Biotech. They are Alan Brochstein, Matthew Finston & Chris Parry. Finston & Parry have both openly taken credit for causing FITX's stock price to drop. Finston has also stated that he is shorting the stock. My concern with bloggers is they can say & do anything they want & there seems to be no repercussions for their actions. I believe they are intentionally trying to manipulate the stock every chance they get. It's my belief this practice is against the law & these individuals should be prosecuted to the full extent of the law for securities fraud. The CEO's of companies are not allowed to pump their stocks. Why should bloggers not be held to the same standards? With all the attacks & delays FITX's price per share has dropped 92.6% from February 21, 2014 to March 30, 2015.

My final & biggest complaint is lodged at an author for the Globe & Mail by the name of Grant Robertson. Beginning on December 19, 2014 he began an all out attack on Cen Biotech. He wrote twelve consecutive articles from 12/19/14 thru 3/25/15 tearing down Cen Biotech & a thirteenth article on 3/27/15. He quoted bloggers Matthew Finston & Chris Parry as his sources of information in the first article & repeated the contents of the first article in every subsequent article he wrote. His articles rarely quoted a legitimate source that could be verified & his writing style is one more like he's suggesting what he thinks might have or could have happened, rather than actual facts. All of his articles were written right after the stock started to climb organically or a positive press release came out. Robertson has been rumored to be linked to Tilray which is one of Cen Biotech's competitors. I don't know if that means anything or not, but it bears looking into as a potential conflict of interest. It's my opinion that Grant Robertson is intentionally manipulating Cen Biotech's stock for some sort of political or financial gain. The one thing that I believe confirms my opinion is that every negative article he wrote about Cen Biotech had the comments sections closed so that no one could dispute his false claims & yet, every other non Cen Biotech article he's written has the comments section open for his readers to comment. When I click on the comments link in the Cen Biotech articles I get the following response:

If not letting anyone respond to his false accusations against only Cen Biotech, while letting his readers comment on virtually every other article he writes isn't stock manipulation, then I don't know what is. As a result of his articles FITX's price per share dropped 50% from 12/19/14 thru 3/30/15. Please look into this.

In summary, I've been investing in stocks since August of 2007. Every stock I've ever bought was manipulated in some way or another but, I've never seen a stock attacked & manipulated like this one. What concerns me most is the freedom that bloggers have to say & do anything without any consequences for their actions. In many instances this costs the average investor large sums of money & destroys their confidence that we're on a level playing field. It also undermines the intent of the companies to build a successful business & return value to the shareholders. Confidence in the stock market is further eroded when a legitimate media outlet like the Globe & Mail allows one of their authors to intentionally manipulate a stock with no other purpose than to drive it out of business. My name is [REDACTED] & I'm an investor in an OTC stock called Creative Edge Nutrition which trades under the ticker symbol FITX. It has come to my attention that the Ontario Securities Commission (OSC) has opened an investigation into the actions of Cen Biotech, which is a subsidiary of Creative Edge Nutrition. It has also been suggested they might be working with the Securities & Exchange Commission (SEC) during this investigation.

As an investor that has invested heavily since January of 2014, I would like to get some comments & opinions entered into the case. I have not now or at any time been misled or deceived by the CEO (Mr. Bill Chaaban) & the Board of Directors. In fact, I have been thoroughly impressed with their professionalism & vision for the future.

However, I do have some complaints about the media coverage, bloggers, the town of Lakeshore & Health Canada's handling & subsequent rejection of Cen Biotech's application for a MMPR license to grow, harvest & sell medicinal marijuana. The actions of these four entities have caused my original investment to drop 80% since January of 2014. I do realize there are no guarantees when investing in stocks, but I believe their actions greatly contributed to this loss.

The town of Lakeshore sought out Cen Biotech to open a medicinal marijuana business there to provide jobs & tax revenue. The mayor (Tom Bain), members of council & Sandra Pupatello welcomed Cen Biotech with open arms & visions of expansion. The city helped Cen Biotech select the land in an agricultural zone ensuring them that it was zoned properly. They issued the building permits to build on the land & their inspectors inspected every step of the way. Mr. Chaaban worked with Lakeshore & even made some compromises along the way in order to be a good neighbor & business partner. Then, three neighbors decided they didn't want the facility there after it was already built & hired a lawyer to represent them. Suddenly, the Mayor & council developed amnesia & forgot all about their original promises. They decided that medicinal marijuana should be built on industrial land & modified their by-laws to reflect that. They also wrote a letter to Health Canada asking them to delay the issuance of the license until they could get their new by-laws approved by the county. Along the way we were dismayed by negative and unfounded articles written by Grant Robertson and published by the Globe and Mail among others and the negative "noise" and apparent successful stock manipulation on various public investment boards regarding this company. We never doubted the good intentions of this company. Under the direction of CEN's CEO Mr. Bill Chabaan we were continually impressed and excited due to the transparency he exhibited to his shareholders. We were excited about the value CEN would have as a company dedicated to helping those in need with the benefits of medical marijuana.

After building completion, we patiently waited for months for the arrival of Health Canada's inspectors. There were a few minor omission or errors that were immediately corrected by CEN and Health Canada indicated a license was to follow. In the meantime the Town of Lakeshore officials appeared to be confused and uninformed or perhaps forgetful and began questioning the zoning of this property. The Town of Lakeshore passed a resolution to send a letter to Health Canada regarding the issuance of a license to CEN. This is in direct contradiction to their issuance of a permit to build a facility to grow medical marijuana. This was followed by leaked news by someone in Health Canada that CEN would not receive a license with the subsequent receipt of a letter of license denial by Health Canada.

To sum it up, CEN was welcomed by the Town of Lakeshore, followed the regulations to build based on the laws of Health Canada and built in a timely manner and according to regulations. Then there were the

various media outlets that published negative articles without documented sources, slandering and bashing CEN. Add to that the previously welcoming Town of Lakeshore, now acting confused and forgetful, issuing a letter to Health Canada asking them to deny CEN their license, followed by the denial of a license by Health Canada for no stated reason. This leads me to question what and who was at work here and how and more importantly why this happened.

I list of questions that I feel require investigation and answers are as follows:

1. Who has been issued a license to grow MMJ by Health Canada?
2. Under what procedure or standing procedure have these licenses been issued?
3. How are CEN's circumstances different from anyone else who has been issued a license?
4. Is this a case of selective enforcement by Health Canada?
5. On what basis has anyone been refused a license?
6. What omissions or errors were committed by CEN to deny them a license?
7. Has there been any communication between Health Canada and the Town of Lakeshore?
8. If there have been any communications between Health Canada and the Town of Lakeshore have they been released to CEN, the Courts and to any investigating agency?
9. Has there been a request by the Courts and the investigating agencies for all communications between the Town of Lakeshore and Health Canada?
10. Has there been a request for the rationale for zoning change or modification by the Town of Lakeshore with dates and attendees of any meetings by the Town of Lakeshore officials by the courts or any investigating agency?

Selected enforcement of laws in any jurisdiction raise questions about that jurisdiction's access to negative or positive information and trading of the stock involved.

As stockholders in this company we invested in good faith after doing research on this company, the Town of Lakeshore and the Health Canada's MMPR laws. We are very disappointed in the current state of affairs as we feel CEN has acted above board with their shareholders and patients in mind and have been above board in their communication with their shareholders. We feel we have not been misled by CEN but do feel misled by the Town of Lakeshore and Health Canada who appeared to have influenced by the media and under the circumstances they should be issued a license.


